Fisher Manufacturing Company makes the following limited warranties. These limited warranties extend to the original Fisher Manufacturing Company purchaser only and are not eligible to be transferred.

Fisher Manufacturing Company warrants its products and parts thereof (except as noted below) against defects in materials or workmanship for a period shown below on the chart after the date of the original purchase. During this period Fisher Manufacturing Company will replace a defective product or part without charge to you, provided that the entire product is delivered to Fisher Manufacturing Company. All transportation and insurance charges for shipping the product to and from Fisher Manufacturing Company must be provided by you. Charges for transportation and insurance may, at the option of Fisher Manufacturing Company, be refunded depending upon our investigation of the warranty claim. This warranty does not cover the external finish (except at the date of the original purchase) or labor costs not specifically authorized by Fisher Manufacturing Company.
